

Service Name: Approval of Boiler Manufacturer under The Boilers Act, 1923

Brief about the service: The registration of boiler manufacturers under The Boilers Act, 1923 refers to the official process by which a manufacturer of boilers is recognized and authorized by the regulatory authority, typically the Chief Inspector of Boilers in a state, to engage in the construction and fabrication of boilers and boiler components. This process is designed to ensure that the manufacturers comply with the safety standards and technical specifications prescribed under the Act and the Indian Boiler Regulations (IBR).

Action by User Type	Stages/Steps	Time taken for approval
	Applicant fills up the application form and questionnaire in Form D as prescribed under the Goa Boilers Rules, 1983	
User / Investor	Submits the application along with questionnaire in Form D and treasury receipt for payment of fees specified in rule 38-A of The Goa Boiler Rules, 1983.	
Department	Area Inspector of Boilers (AIB) does the initial scrutiny of all the relevant documents along with the application and the application is forwarded to Chief Inspector of Boilers (CIB) along with verification remarks for evaluation. Chief Inspector of Boilers (CIB) directs the Area Inspector of Boiler's (AIB) to conduct physical inspection of the firm to check the equipment and facilities, supervisory personnel engaged and quality control procedure in place of the applicant firm to ensure that the manufacturers comply with the safety standards and technical specifications. Area Inspector of Boilers (AIB) conducts physical inspection of the firm and submits report.	21 working days
	CIB verifies the report and grants approval to the firm for manufacture of boilers subject to such conditions and limitations
