In exercise of the powers conferred by sub-sections (1) and (2) of Section 17A of the Goa Shops and Establishments Act, 1973 (Goa Act 13 of 1974), the Government of Goa, thereby authorizing hereby allows woman workers to work in shop or establishment between the hours of 7.00 p.m. to 6.00 a.m. with effect from the date of publication of this notification in the Official Gazette, subject to the following conditions for ensuring safety of women, namely:-

- (i) Employment between the hours of 7.00 p.m. to 6.00 a.m. shall be with the consent in writing of the concerned woman workers;
- (ii) Adequate, secure and safe transportation facilities shall be provided to the women worker to pick-up and drop such worker at her residence;
- (iii) CCTV cameras shall be provided and maintained in the work areas where women workers will be employed;
- (iv) Provide safe, secure and healthy working condition such that no women worker is disadvantaged in connection with her employment.

This Notification shall come into force on the date of its publication in the Official Gazette.
