### PROSPECTUS

### Four Weeks Certificate Course In Safety & Health for Supervisory Personnel working in Hazardous Process Industries.

## THE COURSE PERSPECTIVE:

Section 41C (b) of the Factories Act, 1948, has imposed specific responsibilities on the Occupier in relation to hazardous processes which states that every Occupier of the factory involving any hazardous process shall appoint persons who posses qualification & experience in handling hazardous substances and are competent to supervise such handling within the factory and the Chief Inspector may require the supervisor to undergo training in Health & Safety.

Realizing the need of the above mentioned qualified persons, this Four Weeks Certificate Course is being conducted at Inspectorate of Factories & Boilers, Altinho, Panaji, to provide an opportunity to gain insight of safe system & procedures. After this course, the participants will be able to discuss / identify and control the hazards that will result into great degree of risk reduction.

#### **METHODOLOGY & COURSE CONTENTS:**

Methodologies to be used during the course will be lectures, discussions, case studies, relevant film shows & factory visits. The participants will be required to visit a factory and to prepare a report on Factory Visit as a requirement under the syllabus.

At the end of the course, the participants will be required to undergo an objective type written examination on the topics given below. Certificates will be awarded to the successful candidates.

- Statutory Provisions
- Basic principles of Accident prevention
- Techniques of identification of Hazard
- Accident prevention and Control Techniques
- Chemical hazards & Specific Control Measures
- Fire & Explosion Hazards
- Health Hazards due to chemical exposures
- Emergency Preparedness
- Others

# DATES & TIMINGS:

The course will be conducted from 3<sup>rd</sup> March,2025 to 29<sup>th</sup> March,2025. The teaching hours will be from <u>10 A.M. to 5 P.M</u>. on all week days except Sunday and Public Holidays.

# FACULTY:

The faculty consists of experts from various disciplines of the Department, specialists from Industries, different Institutions & Government departments.

**VENUE:** Inspectorate of Factories and Boilers, Altinho, Panaji-Goa.

# **ELIGIBILITY FOR ADMISSION:**

- a degree in any branch of engineering or technology or a masters degree in Science (Physics or Chemistry) or a masters degree in Pharmacy, from recognized institution, with two years of experience of working in a factory involved in hazardous process, or
- (ii) a degree in Science (Physics or Chemistry) or a degree in Pharmacy or a diploma in any branch of engineering or technology, from a recognized

institution, with five years of experience of working in a factory involved in hazardous process.

# FEE & OTHER EXPENSES:

1. **<u>Course Fee</u>**: Rs 15,000/- for the entire course (non- refundable)

The fee is payable immediately on being offered the admission & before joining the course by a crossed demand draft drawn in favour of Chief Inspector of Factories & Boilers, Goa payable at Panaji and after payment e-Receipt to be submitted to this office.

2. <u>Other Expenses</u>: Participants will have to pay for Tea, snacks and lunch provided at venue and also will have to make their own arrangements to visit factories at given date and time.

Nomination(s) in the prescribed proforma, along with the <u>course fees</u> of Rs.15,000/-(Rupees fifteen Thousand only) per participant, in the form of demand draft drawn in favour of Chief Inspector of Factories & Boilers, Goa payable at Panaji and if fees paid online then e-Receipt may be sent to Shri Premanand Gaude, Course Coordinator, Inspectorate of Factories & Boilers, Altinho, <u>Panaji-Goa, so as to</u> reach on or before **05<sup>th</sup> February**,**2025**. Application duly filled in with one additional photograph accompanied by self-attested copies of certificates & mark sheets of **qualifying examinations** and experience certificates from employers for the **qualifying period** shall be forwarded by the sponsoring organization. **The above testimonials in original will have to be produced by the candidates at the time of admission for verification**.
